INTRODUCTION

Jacobs (1993 21) said that the tendency can be elaborated by understanding that language as the written form is used as a medium in expressing ideas—called meaning, but this point does not mean that linguistic structures are not the one in scientific discourse because in principle the language covers the whole aspects of human life in culture. 
