Noun Phrase is the part of syntax and grammar. It has rules and deregulations that must be obeyed. Without the correct arrangement of noun, the meaning of the sentence can make the people confused. Hence, the research questions of this research are: 1) What are the constructions of noun phrase in political articles in The Jakarta Post? 2) What are the functions of noun phrase in political articles in The Jakarta Post? The researcher uses Essentials Grammar theory by Nelson (2002). The research method of this research is descriptive qualitative method. Technique of collecting data of this research uses five steps, which are selecting, reading, highlighting, categorizing, and writing. Meanwhile, Technique of analyzing data of this research uses three steps, which are identifying, analyzing and concluding. From the data analysis, the findings show that the constructions of noun phrase in the political news in The Jakarta Post is dominated by the construction of pre-modifier + head (58 data), the construction of head + post-modifier (10 data) and the construction of pre-modifier + head + post-modifier (6 data). Based on the findings, it can be concluded that the construction of pre-modifier + head is the construction that is used dominantly than the other two constructions which are head + post-modifier and pre-modifier + head + post-modifier. Moreover, the noun phrase can occupy the most functions of the sentence depending on the types of the sentence such as subject, direct object, indirect object, subject complement, object complement and object of preposition in adverbial.

ABSTRAK

Frasa nomina adalah bagian dari sintaks dan tata bahasa. Frasa nomina memiliki aturan dan deregulasi yang harus dipatuhi. Tanpa penyusunan nomina yang benar, makna dari kalimatnya akan membuat orang bingung. Oleh karena itu, pertanyaan penelitian dari penelitian ini adalah: 1) Apa konstruksi frasa nomina dalam artikel politik di The Jakarta Post? 2) Apa fungsi dari frasa nomina dalam sebuah kalimat dari artikel politik di The Jakarta Post? Peneliti menggunakan teori Essentials Grammar oleh Nelson (2002). Metode penelitian dalam penelitian ini adalah metode deskriptif kualitatif. Teknik pengumpulan data penelitian ini menggunakan lima langkah. Yakni memilih, membaca, menyoroti, mengelompokkan, dan menulis. Sementara itu, Teknik menganalisis data penelitian ini menggunakan tiga langkah. Yakni mengidentifikasi, menganalisis, dan menyimpulkan. Dari analisis data, temuan menunjukkan bahwa konstruksi frase nomina dalam artikel politik di The Jakarta Post didominasi oleh konstruksi pre-modifier + head (58 data), konstruksi head + post-modifier (10 data) dan pembangunan pre-modifier + head + post-modifier (6 data). Berdasarkan temuan, dapat disimpulkan bahwa konstruksi pre-modifier + head adalah konstruksi yang paling banyak digunakan daripada dua konstruksi lainnya yaitu head + post-modifier dan pre-modifier + head + post-modifier. Selain itu, frasa nomina dapat menempati sebagian besar fungsi kalimat tergantung pada jenis kalimatnya.
