

## ABSTRAK

Penyelenggara pemerintahan desa untuk dapat mencapai tujuan kinerjanya maka diperlukan suatu lembaga untuk bertugas melakukan transformasional dan pengawasan terhadap kinerja desa maka berdasarkan Undang-undang UU No. 32 tahun 2004 pasal 209 dinyatakan bahwa BPD berfungsi menetapkan peraturan desa bersama kepala desa, menampung dan menyalurkan aspirasi masyarakat. Badan Permusyawaratan Desa (BPD) memiliki peran penting dalam membela pemerintahan desa menurut Peraturan Menteri Dalam Negeri Republik Indonesia Nomor. 110 Tahun 2016 menjelaskan tentang fungsi BPD ialah membahas dan menyepakati rancangan peraturan desa bersama Kepala Desa, menampung dan menyalurkan aspirasi masyarakat desa dan melakukan pengawasan kinerja kepala desa. Berdasarkan penelitian peneliti menemukan masalah yang terjadi dilapangan yaitu masyarakat sepenuhnya belum mengetahui peran dan fungsi dari BPD, peran pengawasan BPD belum optimal, dan belum adanya optimalisasi kerja sama antara pihak BPD dan pihak Desa. Jenis metode penelitian dalam penelitian ini adalah metode kualitatif yang bertujuan untuk mengungkapkan, menggambarkan, menyimpulkan hasil pemecahan masalah melalui cara tertentu sesuai dengan prosedur penelitiannya. Hasil penelitian dapat disimpulkan Peranan BPD dalam memberikan informasi terhadap aspirasi masyarakat di Desa Purwasari Kecamatan Cicurug cukup maksimal dikarenakan aspirasi masyarakat dapat tersampaikan di forum rapat desa, peran Badan Permusyawaratan Desa (BPD) dengan tahapan perencanaan, pelaksanaan dan pengawasan terhadap kinerja desa, agar pembangunan desa dapat maksimal sesuai dengan kepentingan masyarakat. Faktor pendukung adanya dukungan dan partisipasi masyarakat, hubungan kerja sama yang baik antara BPD dengan Pemerintah Desa, dan faktor penghambat kurangnya tunjangan, sarana prasarana yang kurang maksimal, kurangnya SDM anggota BPD, adanya pro maupun kontra dari masyarakat terhadap setiap keputusan yang ditetapkan.

## **ABSTRACT**

*For village government administrators to be able to achieve their performance goals, an institution is needed to carry out transformational and supervisory duties on village performance. 32 of 2004 article 209 it is stated that the BPD has the function of establishing village regulations with the village head, accommodating and channeling the aspirations of the community. The Village Consultative Body (BPD) has an important role in village government institutions according to the Regulation of the Minister of Home Affairs of the Republic of Indonesia Number. 110 of 2016 explains that the function of the BPD is to discuss and agree on draft village regulations with the Village Head, accommodate and channel the aspirations of the village community and supervise the performance of the village head. Based on the research, the researchers found problems that occurred in the field, namely that the community did not fully know the role and function of the BPD, the supervisory role of the BPD was not optimal, and there was no optimization of cooperation between the BPD and the village. The type of research method in this research is a qualitative method which aims to reveal, describe, and conclude the results of problem solving in a certain way according to the research procedure. The results of the study can be concluded that the role of the BPD in providing information on the aspirations of the community in Purwasari Village, Cicurug District is quite maximal because community aspirations can be conveyed in village meeting forums, the role of the Village Consultative Body (BPD) with the stages of planning, implementing and monitoring village performance, so that village development can be maximized in accordance with the interests of society. The supporting factors are the support and participation of the community, the good cooperative relationship between the BPD and the Village Government, and the inhibiting factors are the lack of allowances, the less optimal infrastructure, the lack of human resources for BPD members, the pros and cons of the community towards each decision made.*
