CHAPTER I

INTRODUCTION

The first chapter is divided by some matters; those are background of research, statement of problem, significance of research, conceptual framework, the definition of key term and organization of writing.

1.1 Background of Research

Most of literary studies are concerned to the analysis on novels. Novels involved many characters and tell a complex story by placing the characters in a number of different situations. According to Wikipedia novel is a long narrative, normally in prose, which describes fictional characters and events, usually in the form of a sequential story. Thus even though the novel's characters and actions are imaginary, they are in some sense 'representative of real life'.

One of literary works by Jane Austen is the novel entitled *Mansfield Park* which in regarded to enrich the feminist ideas. This novel exposes women who are a subject of abuse. It tells about women weakness that oppressed by society. The main character is Fanny Price, she lives with her aunt and uncle because her parent is poor. Thus Fanny lives with her aunt and uncle, she is pressured to take a rule. Fanny grows up shy and differential. In her live, Fanny always feels pressured by patriarchal society. Fanny has to accept that she has low education in comparison with Maria and Julia Bertram, so she has to fight for shows other her ability.

The powerless of woman is caused by patriarchal virtues that are promoted by man. One of the famous quotes is also related to patriarchy found in Athens "Men are free to roam outside, but the woman must stay inside" (Chinese Patriarchy: Wikipedia). A cliché of classical text, which is repeated throughout the tradition, is the familiar notion that men govern the outer world, while women govern the home. These, patriarchal virtues make men dominant in all aspect. Men have power to constrain woman as the result of their superiority. Men's superiority is the cause that makes woman lost their liberation in society.

Wollstonecraft in Nurrachman, wants equality between men and women. She says that "in fact the female mind has been so totally neglected, that knowledge was only to be acquired from this muddy source, till from reading novels some women of superior talents learned to despite" (2014: 152). Women have the same rights and obligation as men. Not just women who must always follow the orders from men however the women also has the same priority in his life.

Wollstonecraft's theory shows that low levels of education which is owned by women because of restrictions on the rights of women and men in terms of education. Mary wants that women do not have to always rely on man. In another case, Betty Friedan in Priyawan says that we can no longer ignore that voice within woman says: "I want something more than my husband and my children and my home" (2014: 165).

Beauvoir found out the description about the reason why man named man as 'the self' and woman as 'the other'. She speculated that man looked himself as a subject who could risk his soul in battle, man looked woman as an object who only could give life. It is clear, by Beauvoir's estimation above, that being a wife and a mother can limits woman freedom.

In this research, the researcher takes focus on the woman characters in Jane Austen novel. It's because the researcher assumes in Jane Austen novel there is story telling technique which make woman characters in a novel as vocal point in story of novel itself. In the novel woman characters take dominant act in story. The dominant act refers to the woman character which takes the character that carry out the every event from the novel. Luxemburg in AzzisFameia (2013: 7) states that everything which doing by the character in the story has a purpose to give direction to the reader to get the essence of story. From this point, the researcher assumes that the domination woman characters in the novel has the purpose too and has relation with the essence of the novel.

Showalter in Nur Indah (2009: 8) said that feminist criticism can be divided into two distinct varieties. The first type is concerned with woman as readers. The second type is concerned with women as writers with women as producers of textual meaning, with history, themes, genres, and structures of literature by woman. *Mansfield Park* by Jane Austen are full of the unique language of woman. It is like a journal of Jane Austen which describes her own story, her feelings and her thoughts.

Based on this consideration, this research focuses on the value of woman in the social life, which in the end leads to the existence of feminist views in Jane

Austen's Mansfield Park. Thus, this research is entitled "The Values of Woman Characters' Liberation in Jane Austen's *Mansfield Park*."

1.2 Statement of Problem

Based on the research background above, the researcher limits the analysis on Mansfield Park into two questions such as:

- 1. How are feminist values represented in Jane Austen's *Mansfield Park*?
- 2. How are woman liberation represented in Jane Austen's *Mansfield Park* based on the view of two woman characters?
