### BAB I

## INTRODUCTION

#### 1.1 Research Background

Feminism is an awareness of the oppression and exploitation of women that occurs both in the family, at work, and in society and there is conscious action of men and women to change the situation lexically (Sai'dah, 2003). Feminism is a movement that demands full equality of rights between women and men. The definition of feminism can change due to the understanding or views of feminists which are based on historical and cultural realities, as well as the level of awareness of perceptions and behavior. It is important to note that the term "feminism" did not appear during the time when Mary Wollstonecraft wrote this book. However, this research provides evidence that *A Vindication of the Rights of Woman* belongs to the realm of liberal feminism, advocating for gender equality.

Liberal feminism was first born in the 18th century, formulated by Mary Wollstonecraft in her writing *A Vindication of the Right of Women* (1759-1799) and in the 19th century by John Stuart Mill in his book *Subjection of Women* and Harriet Taylor Mills in her book *Enfranchisement of Women*. Then in the 20th century, Betty Friedan in *The Feminine Mystique* and *The Second Stage*. This Liberal Feminist bases her thoughts on the liberal concept which emphasizes that women and men are created equal and have the same rights and should also have the same opportunities.

Liberal feminists want women to be free from oppressive gender roles. They argue that in a patriarchal society suitable jobs for women are associated with feminine traits such as teacher, nurse, secretary, cashier at a bank etc. The challenge to these stereotypes must be through androgynous education -which has male and female dimensions- both at school and at home. Androgyny has helped them in achieving freedom, equality and justice.

The state is also responsible for ensuring that there is no discrimination against women, either sexual or income, and guaranteeing that women are free from sexual harassment, rape and violence. Liberal feminists are very important in the feminist movement with their struggle for women in the west to achieve equal rights, eliminate discrimination in the workplace and change laws that are more favorable to women. This is what made the researcher interested in researching liberal feminism in A Vindication of The Rights of Woman.

Mary Wollstonecraft, in her book *A Vindication of the Right of Women* describes a European society that is experiencing a decline where women are confined at home and are not given the opportunity to enter the labor market and do household chores. While men are given the freedom to develop themselves as optimally as possible. Whereas if women are given the same opportunity, they can develop themselves optimally, as long as women are also given the same education as men.

Wollstonecraft also criticized Email, a novel by Jean Jackques Rosseau which differentiated male and female education. Education for men places more emphasis on rationality – studying natural sciences, social sciences and humanities - because later they will be responsible as the head of the family while education for women places more emphasis on emotional - learning poetry, art-because women will become wives who are understanding, responsive, caring and motherly. The solution offered by Wollstonecraft is to educate women the same as educating men by teaching women also rationality so that women are able to be "self" and not become "man's toys".

Mary Wollstonecraft, married name Mary Wollstonecraft Godwin (born April 27, 1759, London, England-died September 10, 1797, London), English writer and passionate advocate of educational and social equality for women. *A Vindication of The Right of Woman* by Mary Wollstonecraft can be said as a non-fiction genre of literature because based on facts, real events, and accurate information. Also, the

writer focuses on real-life events and conducts careful research to gather accurate and reliable information.

The research on this book has been examined by some researchers. First, research by Nareswari (2019) *Liberal Feminism Seen Through the Main Female Character in Educating Rita Movie*. Her research used Library Research method. Educating Rita is the primary source of this research. The secondary sources of this research are several books, journals, and some internet sites related to this research.
