#### **CHAPTER I**

#### INTRODUCTION

#### 1.1 Background of the Research

Infidelity is a relationship between two people who love each other physically or emotionally in a context that is not legitimate partner (Morrow,1995), intimately connected with an affair relationship which is a gratification of lust based on needs and behavior in which someone who is married or in a relationship has sex with someone who is not their wife, husband, or regular partner. It is infidelity in novel *The Great* Gatsby by F. Scott Fitzgerald. Tom loved Martyle, who was the wife of Mechanic, but tom also loved his wife Daisy. Daisy knew that her husband had another dream woman, but she was not so concerned, and it resulted in committing infidelity with his exboyfriend, Gatsby. A similar case is also found in the novel Pada Sebuah Kapal by N.H. Dini. After her fiancé, Saputro died in a plane crash, Sri finally married Charles Vincent. The couple then settled in Kobe, Japan. Even though she had a child from the French diplomat, Sri did not feel happy. Unexpectedly, on a trip Sri rediscovered the intimacy and tenderness she had longed for so long in Michel Dubanton, the ship's commander who was married and had two children. Sri, who didn't love her husband from the beginning also falls in love with Michael. We know that a infidelity has many motifs, and a lot of influences which are essentially the spiritual needs of human beings.

Talk about humans with all the problems they face in life related to love and household matters. One of the problems that often occurs is Infidelity. Infidelity is phenomenon that often occur in a relationship of husband and wife. Infidelity is a broken agreement, implicit or explicit, that is considered vital to the integrity of relationship. Charles' treatment of Sri was one of the reasons why Sri had an affair with Michel because Sri was looking for a man who could respect her and her love. This novel is a rebellion against the confines of marital values by releasing all ties of color and nation as well as the way of marriage which makes the people who created these values feel unhappy (Guidelines, 20 November 1973).

There are many differences and similarities between *The Great Gatsby* and *Pada Sebuah Kapal*. There are many factors such as culture, religion, moral values,

and relationship between different communities. In this thesis is interested in finding the motifs of infidelity found in *The Great Gatsby* and *Pada Sebuah Kapal*.

Both of the novels written by F. Scott Fitzgerald and N.H. Dini reveal the infidelity causes that happen to the main characters, and anything to do within infidelity nowadays. Base on both of the novels, the researcher is interested in comparing both of these novels related to the culture differences, the nation of the novels, the financial problem and the community system is an interesting. And the researcher will reveal character and motif in the both of the novels. These thing will make the writer formulate the problem as before.
