CHAPTER I INTRODUCTION

1.1 Research Background

There are several types of literature, including film, novel, and poetry. Some films have trilogy components that are linked to one another (Adi, 2016). The movie is a moving image, and the movements are referred to as intermittent motions, which occur solely due to the human eye and brain's limited ability to capture many visual changes in a fraction of a second. Many parts of filmmaking have evolved throughout time, from early experiments to becoming a worldwide entertainment business, including production technology, storytelling methods, genres, and today's prominent cultural influences.

Before the 1880s, before contemporary movies, there were various types of visual amusement, such as shadows and optical game that were used to entertain people. However, no camera technology existed to record and play moving images. The term "prehistory of cinema" refers to the period preceding contemporary cinema, which emerged in the late nineteenth century. There was no contemporary technology available at the time, such as camcorders or projectors.

In the present day, film is a popular form of entertainment, enjoyed by various demographics and age groups. Film itself can be considered a modern form of literary work because it incorporates various literary elements such as structure, narration, characterization, theme, meaning, and dialogue, combined with audio visual elements like visuals, sound, music, and special effects. According to Adi (2011), film is a form of literary work, and the history of film is also influenced by the history of literary works.

Also Damono (2006) explain that movie can be categorized as literary work because movie have some narrative art like audio visual and language, language in movie called shot, and the order of shot could be read as narration. It continuously affects each of them, including the image, sound, and movement of people on the

screen, and makes the film the most powerful realistic art. According to Mintz (1983), the product of popular literature is responsible for those involved in making it so that its motifs and functions are more valuable than the product's aesthetics. However, the creation of popular literary works is not only for mass consumption but also for several hidden purposes. Thus, analysing and criticizing popular literary works, including films, is necessary.

The term genre refers to the grouping of media materials that share similar qualities. "Genre has a function as a label, which gives an idea of the audience's pleasure and what kind they can feel when they enjoy the product," says Hesmondhalgh (2009:23). "Genres are used to categorize works of art according to their themes, styles, and other components." Audiences can use genre classification to know what to expect from a particular work. "Film genre classification aids viewers in understanding what to anticipate from a picture" (Stokes, 2007:91). Among the most popular genres are romance, mystery, science fiction, fantasy, horror, and others. However, it is also common for compositions to cross over or blend genres combining elements in novel and inventive ways from other genres. Various movie genres can be divided into groups according to the type of story being told, like action, Horror, romance, comedy, or drama. They might also be determined by the environment, such as in historical dramas, science fiction, and westerns. Moreover, movie genres can be categorized based on the intended audience, for example, children's, teen adult films, or rather, movies.

To construct the genre, popular fiction qualities such as topics, presenting tactics, and language that should represent public taste are used. The formulas are parts of popular literature. There are several subgenres of romance, mystery, and adventure in the widely read literary genre. Each genre has its own set of formulae since each has its own collection of subjects. A technique for assessing the most famous literary works in one genre will not be applicable to other genres. According to (Adi, 2016) if the theme, presenting style, and composition follow a common pattern, a work of literature can be referred to as a popular literary work. Popular fiction's traits, including its topics, presentational strategies, and The genre is created by applying words that ought to represent popular taste. The elements of popular literature are formulas. Typically,

there are several subgenres of adventure, mystery, and romance in the widely read literary kind. Every genre has a unique set of subjects and formulas. A system for evaluating the most well-known books in a certain genre won't be used to analyze other genres.

There are two separate detective models in the mystery: a hard-boiled detective and a classic detective. The focus of this research is to find out the hard-boiled detective formula applied in films and reveal the effect of the action pattern of the hard-boiled detective formula on the main character in the film Marlowe that can be studied. The hard-boiled detective formula is also something that can be found in achieving research. Marlowe visits Cavendish to tell her of Peterson's demise, while also meeting the Pacific's owner, Philip O'Reilly, the soon-to-be Ambassador to England. Cavendish reveals she has seen Peterson since his supposed death, driving past her in Tijuana. Annoyed at her withholding this information, Marlowe goes to leave, running into Cavendish's mother, film star Dorothy Quincannon, who fails to learn what service Marlowe is providing to her daughter.

The terms hard-boiled formula consists of the detective as hero, suspense and threat, modern city as background, the role of the woman, and the change meaning. The relation between hard-boiled detective formula and *Marlowe* is this the movie have the pattern of hard-boiled detective formula. Marlowe was chosen as the object to analysis because this film is a film that tells the story of a famous fictional detective, namely Phillip Marlowe, who has had several films about him. 1.2 Statement of Problem


